Individual Professional Development Plans

1. An educator shall have an individual professional development plan in place for each of the 5 years of validity for each Initial Professional, Professional, and Advanced Professional license issued to the educator.
2. An educator shall ensure this individual professional development plan includes a minimum of 90 professional development points.
3. Educators who are not employed with a local school system, State-operated school, or nonpublic school approved under COMAR 13A.09.10 are responsible for developing their own individual professional development plan.

Professional Development Points

The Department shall measure professional development activities as follows:

1. 1 clock hour is equivalent to one PDP.
2. 1 semester hour is equivalent to 15 PDPs.
3. One Department-approved continuing professional development credit is equivalent to 15 PDPs.
4. One continuing education unit is equivalent to ten PDPs.

Please refer to the [Code of Maryland Regulations](#) 13A.12.02, 13A.12.03, 13A.12.04, and 13A.12.05 for specific parameters for how professional development points can be accrued.

Senior Teacher Waiver

If you complete or have completed at least 25 years of public or approved non-public professional school service, or if you are or will be at least 55 years of age any time within the validity dates of this license, you may qualify for senior status. Acceptance of senior status is determined by your employer and remains in effect **only while you are employed** by a local public school system, State-operated school, or nonpublic school that recognizes and accepts this allowance. ***Once you terminate your employment, the senior status no longer applies, and you must complete the appropriate requirements for the license you hold.***

Science of Reading Requirement

Beginning on July 1, 2025, all teachers employed in a Maryland local school system, State-operated school, or nonpublic school approved under COMAR 13A.09.10 in a position that requires a license in early childhood education, elementary education, special education, or English to Speakers of Other Languages shall demonstrate proficiency in the knowledge and practices of scientific reading instruction, to include phonemic awareness, phonics, fluency, vocabulary, and comprehension, as follows:

Demonstration of proficiency may be satisfied by submitting one of the following:

- A passing score on a reading instruction test approved by the State Board of Education;
- Completion of coursework or professional learning approved by the Department;
- Submission of attestation of proficiency through observation completed by a Department-recognized assessor; or
- Completion of training provided by the Department in the science of reading for the purpose of fulfilling the requirements of renewal.

A license holder is considered proficient in the knowledge and practices of scientific reading instruction when the requirements of this section have been submitted.
